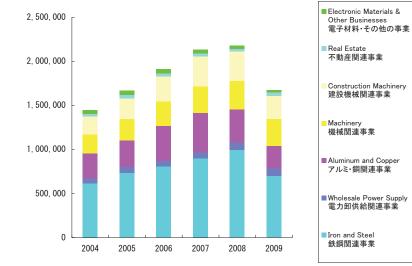

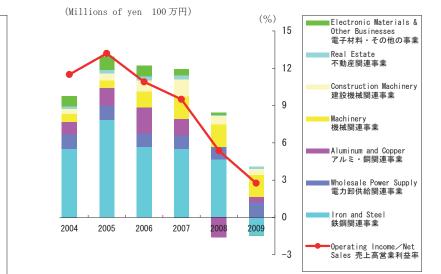

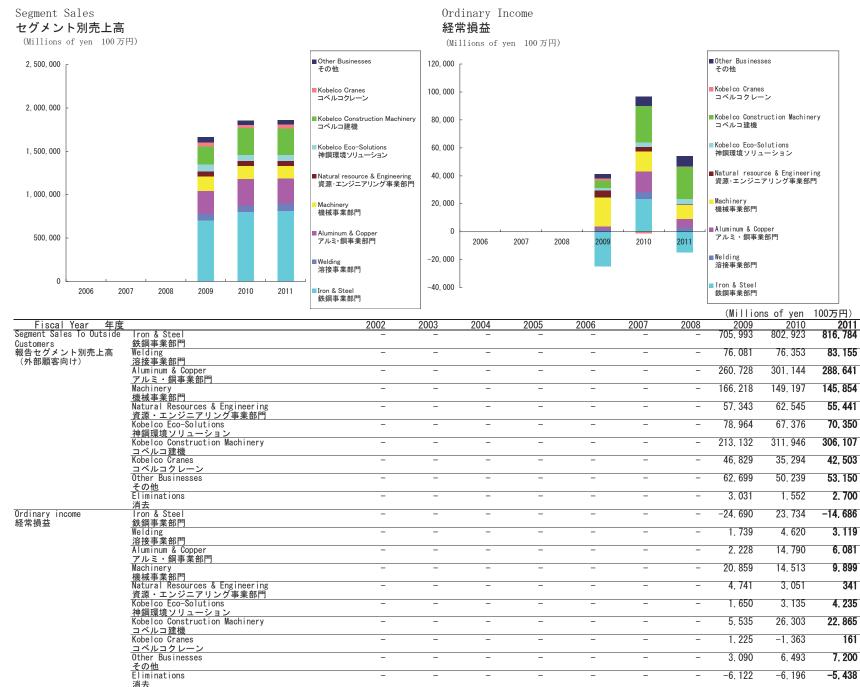


Operating Income and Operating Income/Net Sales 営業損益および売上高営業利益率

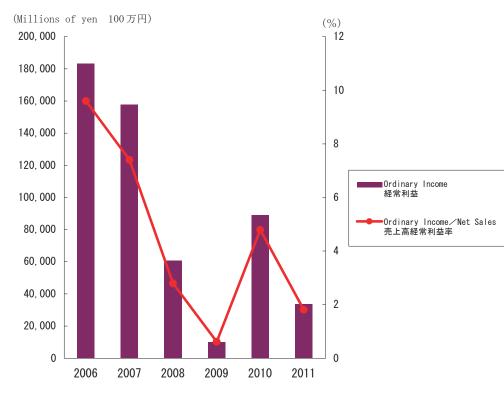

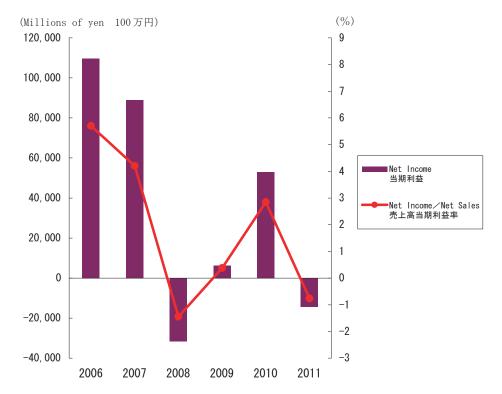

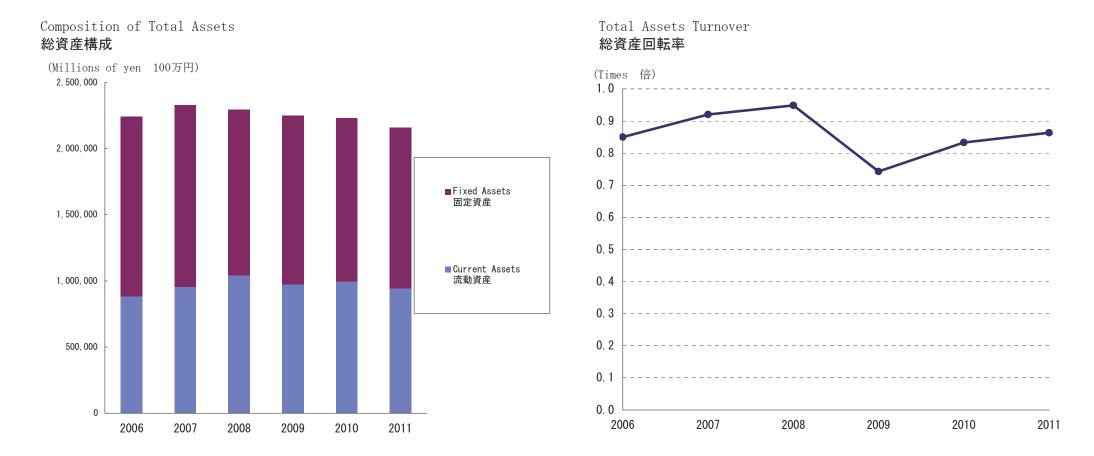
#### Ordinary Income and Ordinary Income/Net Sales 経常利益および売上高経常利益率



#### Net Income and Net Income/Net Sales 当期利益および売上高当期利益率



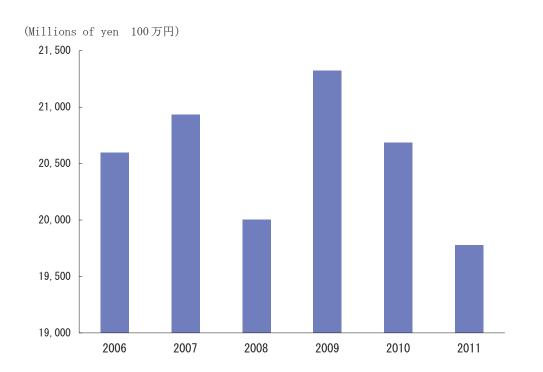

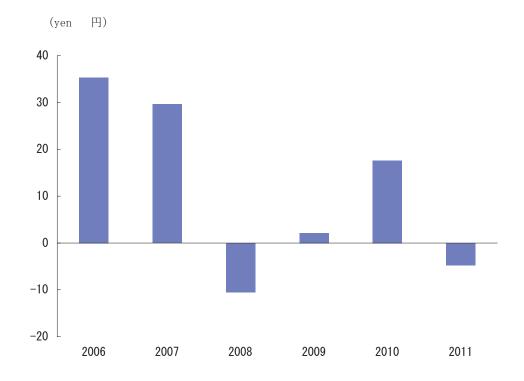

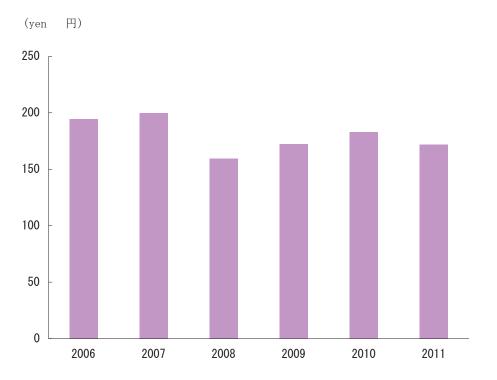

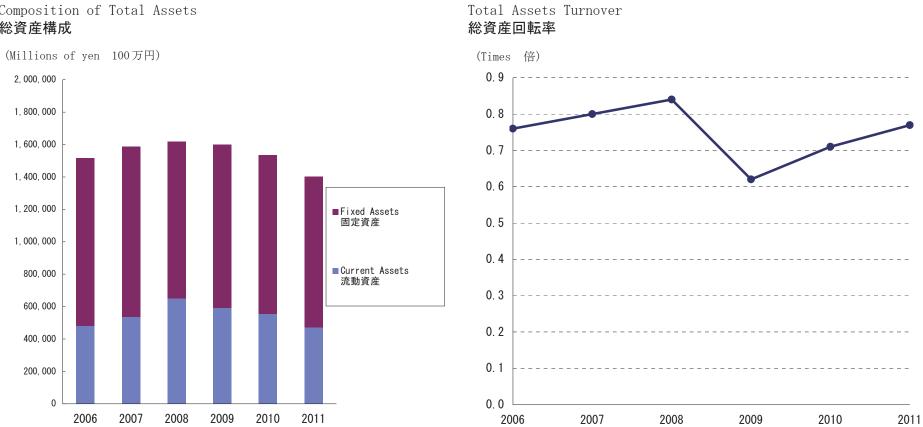

#### 0rdinary Income and Ordinary Income/Net Sales 経常利益および売上高経常利益率(単独)





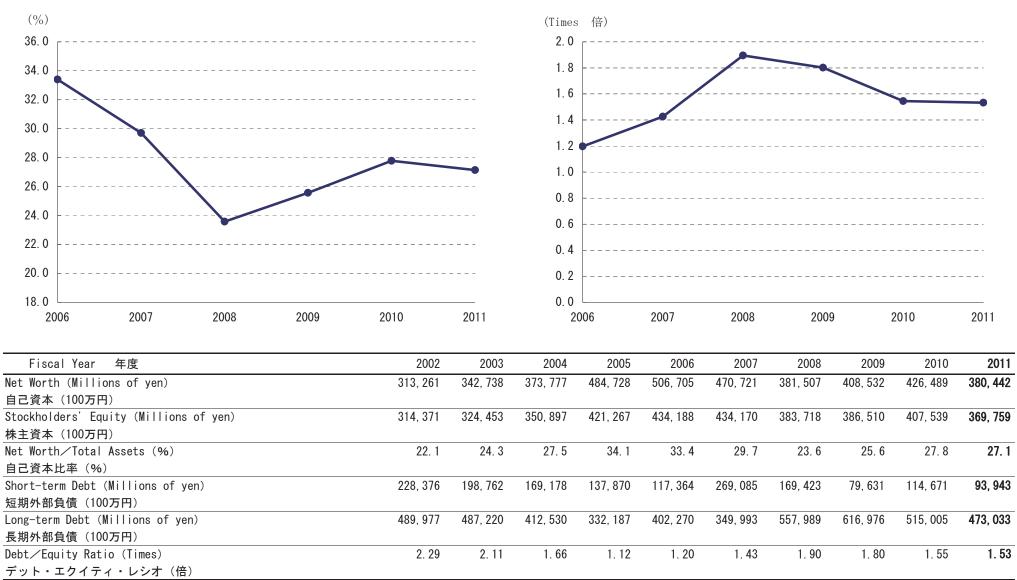
